- A. FOOTWAYS/HIGHWAYS/LIGHTING MATTERS
- 1. General Highways Matters
- 1.1 A20 Corridor Meetings with KCC and TMBC In the past the Council, together with Ditton and East Malling and Larkfield Parishes, have met with KCC and TMBC to discuss proposals for road improvements along the A20 corridor. TMBC recently organised a meeting for their local members and KCC but due to an oversight failed to invite the Parish Councils for which they have apologised and sent out a copy of the notes of the meeting. A copy of these notes are available and will be sent out with the Agenda.

Following a discussion with the Chairman of the Council the Clerk wrote to TMBC expressing our disappointment and asking the following questions which the Council would have raised if it had been there:-

- 1. Is the funding for the Mill Road/Hall Road roundabout in place and is that funding still dependant on S106 money from the Gladman's application at Whitepost Lane?
- 2. If it is too early to take into account the expansion of the Allington Incinerator in the transport modelling when will it be taken into account. The Council is very concerned about this as the number of vehicles from this site will significantly increase and as such could have an impact on the design over both roundabout schemes but particularly Coldharbour.
- 3. When the Mill Road/Hall Road roundabout scheme was discussed previously there was no intention to have signals but these have now been added and perhaps the reasons for this change could be explained.

- 4. The notes state that these improvements are likely to have a beneficial effect on the air quality and perhaps it would be possible to have a more detailed explanation of this and the places where this improvement will take place.
- 5. It sets out that 3 new soakaways will be built to relieve the flooding issues in the vicinity of the Mill Road/Hall Road junction and this sounds different to what had previously been proposed and perhaps the Council could receive an explanation of how this would work and the proposed location of the soakaways.

The Council has not yet received a response to these questions.

2. Eccles Highway Matters.

2.1 – **Speed of Traffic in Bull Lane** – The traffic surveys have been undertaken and KCC have informed the Council that the mean speed at the northern location was 29.9 and 28.8 mph and at the southern location was 32.7 and 34.5 mph. In response to what was the next step KCC have informed the Council that any options could be considered as part of any Highway Improvement Plan discussion. The Council has previously decided not to have a Highway Improvement Plan with KCC.

3. Blue Bell Hill Highway Matters

3.1 - A229 Accidents – The Clerk has asked Peter Homewood if he could obtain from the Director of Highways the accident record for the A229 Blue Bell Hill for the last 2 years.

4. Aylesford Highway Matters

4.1 - **Aylesford Village Square** - The Clerk is awaiting a date for the meeting, from TMBC, to discuss a possible grant funding scheme from Historic England.
