#### **ROAD TRAFFIC REGULATION ACT 1984**

THE KENT COUNTY COUNCIL, acting as Local Traffic Authority and in exercise of its powers under Sections 81, 82, 83 and 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act') as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, proposes to make the following Order.

**REVOCATION, MODIFICATION AND AMENDMENTS**

# STATEMENT of REASON



### THE KENT COUNTY COUNCIL (VARIOUS ROADS, THE BOROUGH OF TONBRIDGE & MALLING) (20MPH, 30MPH, 40MPH, 50MPH SPEED LIMITS AND DERESTRICTED ROADS) AMENDMENT NO.41 ORDER 2021

The Kent County Council as traffic authority intends to make the Order referred to above and as shown on the drawing accompanying this document for the following reasons: -

From 1 April 2013 Kent County Council become responsible for a number of Public Health functions. One of those was the health improvement for the population of Kent. In recent years the demand for the implementation of 20mph schemes had been increasing in response to both local and national campaigns, therefore Kent County Council are intending to implement 20mph Public Health Schemes in the following location, in Larkfield, Tonbridge.

In attrition, the various restrictions are to:-

• Avoid the danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising

The effect of the Order would be to introduce a 20mph speed limit on the following lengths of roads in Larkfield, Tonbridge and Malling:



New Hythe Lane - From its junction with London Road to its junction with Papyrus Way (including access road to playing fields).
