3.1 – Slow sign on slip road off the A229 towards Aylesford currently situated under the bridge. Clerk has asked that Kent Highways move the sign to the actual slip road before the Lower Warren Road junction to improve safety at this junction as well as the junctions under the bridge. Response awaited.

3.2 - Lighting repairs still awaited on the slip road which were scheduled for August. KCC have reported they are still awaiting delivery of new columns. Initial reply received and Clerk will report at the meeting but revised date being sought.
