- 1. General Highways Matters
- 1.1 **Highway Improvement Plan** In accordance with the suggestion of KALC the Clerk has taken up this matter with the Local KCC Highways team and is awaiting a response in order to start discussions on how the Plan would work in detail.

- 2.1 -Speed of Traffic in Bull Lane The issue of the speed of traffic in Bull Lane will now be taken up as a potential item for the Highway Improvement Plan.

- 3.1 A229 Slip Road Lights KCC have informed the Council that the works have not yet been done. The Clerk is continuing to press them for a conclusion to this project.
- 4. Aylesford Highway Matters
- 4.1 **Aylesford Village Square** Previously it was agreed that with the cost of the whole scheme, including the Consultants fee, being in the region of £40k-50k that it was too much for the Council to fund on its own. It was felt that the right approach was for the Council to look for match funding from other bodies to enable the scheme to proceed.

The Council's local MP Tracey Crouch brought to the Council's attention a new Government initiative about breathing new life into historic high streets across the country. The Clerk is preparing an Expression of Interest application for this scheme.

4.2 – **Closure of Forstal Road** – It was reported at the last meeting that a local resident, speaking on behalf of other residents had commented to the Council how much better have been the roads in the village with the stretch of Forstal Road entering the village being closed. It was also reported that Councillor Base had taken up this matter with the KCC Cabinet Member who had asked his Officers to look at the possible options. No further information has been received as yet.

5. Walderslade Highway Matters

5.1 - Pedestrian Crossing at Tunbury Avenue

At the last meeting the Clerk reported that he had received correspondence from a local resident that had been sent to the KCC requesting a pelican crossing in Tunbury Avenue in the area of the school or the reinstatement of the school crossing patrol. The Committee agreed that the Clerk should follow the matter of the pelican crossing and the removal of the school crossing patrol with KCC.

KCC had responded in respect of the school crossing patrol that this site was allocated a patrol but following several adverts no one had come forward to take up the post. This is the position with 17 other school sites across the County. They did indicate that they will continue to advertise it on a regular basis. No response had been received from KCC re a crossing, however, this can also be followed up through the Highway Improvement Plan process.
