- 2.1 **Speed of Traffic in Bull Lane** The Council has recently received a number of comments about the speed of traffic through Eccles along Bull Lane. It has been indicated that most of the speeding traffic is not from Eccles but just passing through and has increased since the new road and bridge. It has been suggested that traffic calming would be a solution to the problem.

As Members will recall the Council has discussed the possibility of traffic calming with KCC and had a clear indication that they would not undertake such a scheme. However, since then and very recently the Clerk has received from KCC, a significant amount of information re a Highways Improvement Plan which he is currently considering in some detail and will be reporting to this committee on at its next meeting. Traffic Calming schemes are the type of scheme that would be included in the Improvement Plan. It is suggested that this item is discussed alongside any consideration of this Highways Improvement Plan

3. Blue Bell Hill Highway Matters

3.1 - A229 Slip Road Lights - KCC have informed the Council that this is a difficult job involving digging up part of the slip road. They are progressing this matter but as yet have no timeframe for completion of the project. The Clerk is continuing to press them for a conclusion to this project and the Council has just received notification of a closure of the slip road on the night of 22 May.

4. Aylesford Highway Matters

4.1 - **Aylesford Village Square** - At the last meeting of the Committee it was agreed that with the cost of the whole scheme, including the Consultants fee, being in the region of £40k-50k that it was too much for the Council to fund on its own. It was felt that the right approach was for the Council to look for match funding from other bodies to enable the scheme to proceed.

The Council's local MP Tracey Crouch has brought to the Council's attention a new Government initiative about breathing new life into historic high streets across the country. The Clerk will update the Committee further at the meeting.

- 4.2 **Closure of Forstal Road** A local resident, speaking on behalf of other residents has commented to the Council how much better have been the roads in the village with the stretch of Forstal Road entering the village being closed. He has asked the Council to consider the issue and to take up with KCC what are the options that could be implemented that maintains the benefits of the closure whilst not shifting the problems to other roads such as Pratling Street. One option proposed by the local MP Tracey Crouch is making it one way from the Maidstone end.
