Locations – Bull Lane & Greenfield Close, Eccles – Residents have reported problems with parking close to the junction. Double yellow lines are intended to prevent this, in line with the requirements of the Highway Code.

Locations – Woodbury Road & Walsham Road, Walderslade – Residents have reported problems with parking close to the junction. Double yellow lines ae intended to prevent this, in line with the requirements of the Highway Code.

Woodbury Road, Walderslade – Residents have reported problems with obstructive parking. Double yellow lines are intended to prevent this.
