A. FOOTWAYS/HIGHWAYS/LIGHTING MATTERS

1. General Highway Report – No report to this meeting.

2. Eccles Highway Matters

2.1 - Bull Lane/Pilgrims Way junction

Kent Highways have agreed to relook at the feasibility of a Vehicle Activated Speed signs. Awaiting decision.

3. Blue Bell Hill Highway Matters

3.1 – Slow sign on slip road off the A229 towards Aylesford currently situated under the bridge. Clerk has asked that Kent Highways move the sign to the actual slip road before the Lower Warren Road junction to improve safety at this junction as well as the junctions under the bridge. Response awaited. Clerk was asked to pursue. **Clerk**

3.2 - Lighting repairs still awaited on the slip road which were scheduled for August. KCC have reported they are still awaiting delivery of new columns. Clerk has pursued on a more formal basis with the Director of Highways. Date was set for 10 December but postponed due to bad weather.

4. Aylesford Highway Matters

4.1 - **Aylesford Village Square** - Clerk has established up to date contact personnel at TMBC now dealing with this project. Now awaiting conservation agreement to the proposed revised materials which will then be repriced.

4.2 - Aylesford Village/Forstal Road junction

Site meeting held with Kent Highways re proposed improvements to this junction to include safer pedestrian access and improved signage. KH took on board comments from local members. Awaiting report.

4.3 – **Hall Road** – Condition of road from the Somerfield development site. Awaiting response.

5.1 – Tunbury Avenue – Local Members have asked about the potential to introduce a 20mph limit based on air quality in roads around the local school in Tunbury Avenue. Clerk has received the criteria which would need to be met for Tunbury Avenue to be considered together with confirmation that Tunbury Avenue does not meet it. Noted.

Minor repairs and enhancement works to be carried out in-house have commenced.
