A. FOOTWAYS/HIGHWAYS/LIGHTING MATTERS

1. General Highway Report - No report to this meeting.

2. Eccles Highway Matters

2.1 - Proposed **pedestrian crossing** in Bull Lane. Cllr Homewood reported to Council on 17 May that he hopes KCC will commence this project in August 2016.

3. Blue Bell Hill Highway Matters

3.1 - Milestone – Work completed. Awaiting installation by KCC.

4. Aylesford Highway Matters

- 4.1 **Old Bridge Lighting Project** Contractor has suggested upgrading lights at both ends of the bridge to LED which can be adjusted to the required lighting strength and installation. Clerk has confirmed hire costs are appropriate for the work and **order placed.**
- 4.2 **Aylesford Village Square** Meeting held Wednesday 22 June with County Councillor Homewood, KCC representatives, Cllr Balcombe and the Clerk re moving this project forward. Productive meeting at which it was agreed KCC will proceed with the safety audit and when this is completed the Clerk will proceed as follows:

Organise a consultation period for local High Street residents to view and comment on plans.

New street furniture will be purchased to match existing 'Heritage' lamp posts.

Look at including permanent fittings for a Christmas tree

Look at including permanent fittings for a noticeboard

Look at including replacement benches on the south side of the High Street

KCC agreed the purchase of benches and tables from Gallaghers and were also agreeable in principle to using Gallaghers to install whole project. Clerk will therefore discuss this further with Gallaghers to gauge their interest.

4.3 – **A20 congestion between Larkfield and Aylesford** – Clerk reported on the meeting held with other parishes, TMBC and KCC on 7 June at which the Amey report on the A20 was considered. The report contains detailed factual information on the problems faced and particularly identifies the junctions of A20/Hermitage Lane and A20/Quarry Wood. There are however no specific solutions to any of the problems included.

- 4.4 **Hall Road** Resurfacing and road closure to take place on 3 Sunday afternoons commencing 26 June 2016.
- 4.5 **Hall Road Motorway Bridge Fencing** Concerns re condition of fencing and littering have been followed up again. Local (Kings Hill) Highways England inspector has promised inspection week commencing 20 June. No further information received to date.
