#### 4.8 TM/22/01847/TPOC – 22 Catkin close, Walderslade

Oak (T1) in front garden of property Crown lift secondary branches to achieve 6m ground clearance. Reduce radial spread by 2.2m, back to previous prune points. Thin canopy by 10%. Remove dead wood. Sweet Chestnut (T2) in front garden of property - crown lift secondary branches to achieve 6m ground clearance. Remove epicormic growth up to 6m. T1 and T2 of preservation order standing in group W6 of tree preservation order
