5.1 TM/23/00403/FL - 79 Rochester Road Aylesford North

Proposed detached outbuilding and carport (retrospective)

It was **Resolved** to submit the following comment to TMBC.

While the Parish Council notes that the outbuilding and carport is shielded from the main road, the development could be deemed to be out of keeping with the locality as are the characteristics of the building.

The Council considers this as overdevelopment of the site and while there are no shade or light issues to neighbouring properties, serious consideration should be given to the previous condition made that says 'to ensure that the development does not harm the character and appearance of the existing building or visual amenity of the locality...'

It should also be noted that the area where the outbuilding has been built was designated as a landscaped area in the original application for the construction of the dwellings.

The Parish Council requests that these points are taken into consideration when determining the application.

5.2 TM/23/00836/FL - Click Aylesford Frank Sando Way, Aylesford South
