#### 4.1 TM/21/02315/TPOC - 41 Hurst Hill, Walderslade

Works to a Sweet Chestnut (T1) - twin stem. Re-pollard at 7m. Remove epicormic growth up to 7m

#### 4.2 TM/21/02351/FL - 2 Teapot Lane, Aylesford South

Demolition of existing conservatory. Erection of rear and side single storey flat roof extension with insertion of new front door and windows and rooflight into front porch

Lawful Development Certificate Existing: Use of existing building for livery purposes
