### 1. Apologies for Absence

# 4.1 TM/21/02450/FL - Land at Junction Off Fossington Way and Robin Hood Lane Walderslade

Replacement of the 15m monopole with a 17.5m monopole supporting 6no. antennas and ancillary works thereto

Single storey rear extension together with external decking

T1 Pine - Reduce height 3-4m and reduce lateral growth 1.2m T2 Pine - Reduce height 3-4m and reduce lateral growth 1-2m T3 Pine - Reduce height 3-4 m and reduce lateral growth 1m T4 Oak - Reduce branch growing over path and road 3-4M and reduce height of remaining top 2-3m T5 Pine - Reduce height 3-4m and reduce growth 1m T6 Oak - Reduce height 3-4m and lateral growth 2-3m

T1, T2 and T3 Hornbeam - crown lift to 5m from ground level. T4. Hornbeam - crown lift to 4m from ground level. T5. Hornbeam - crown lift to 5m from ground level. To allow more light underneath the canopies of the trees and keep branches extending low and over the garden area

# 4.6 TM/21/02514/FL - Land Adjoining Barming Station Hermitage Lane, Aylesford South

Removal of existing 15m Elara Streetworks Monopole to be replaced with proposed 20m high Hutchison Engineering Orion V1 Streetworks Pole on the existing root foundation and associated ancillary development works

#### 4.7 TM/21/02567/FL - Duchess of Kent Court Hall Road, Aylesford South

# 4.10 KCC/TM/0216/2021 Allington Waste Management Facility, Laverstoke Road, Allington

PROPOSAL: Section 73 application to amend conditions (2), (4), (5), (10), (12), (13), (16), (18), (19), (20), (25), (27), (28), (30) and (31) attached to planning permission TM/20/62 (as amended) to permit amendments to Household Waste Recycling Centre

#### **Bushey Wood (Land at Eccles)**

The Council having recently asked TMBC for longer when putting together its comments is disappointed at only being allowed the usual 21 days to respond to them regarding this proposal, when the application is submitted. The Borough Council have said that under current legislation, it is not possible to give Parishes (nor any statutory consultee) longer than 21 days to respond to an application. It was felt that more than 21 days was needed to be able to go through the documents thoroughly. The Clerk had also asked TMBC if the Parish could have a paper copy of the documents that are submitted to them by the developer so that members can come into the office to view them, but TMBC stated that only selected plans will be made available in larger format. It was suggested the Clerk ask if Trenport would be able to provide a paper copy. The Clerk will ask and report back.
