#### 4.1 TM/22/00117/FL - Aylesford Recreation Ground Forstal Road, Aylesford North

Creation of a Community 3G Football Turf Pitch (FTP) (9188 sq. metres) with associated features including: 3G football turf pitch (7460 sq. metres); 4.5m high ball stop fencing with entrance gates to form an enclosure around FTP perimeter; 1.2m high and 2.0m high pitch barriers with entrance gates internally within fenced FTP enclosure; 2.6m high maintenance equipment storage container (15 sq. metres) within fenced FTP enclosure; 15.0m high LED floodlights (6no.) around FTP perimeter; Hard-standing areas for portable goals storage (720 sq. metres); Hard-standing areas for pedestrian access and circulation (569 sq. metres);1.0m high LED bollard amenity lights (8no.) along pedestrian access; Additional car parking (439 sq. metres) providing 14no. standard parking spaces and vehicular access to the FTP connecting to an established vehicular entrance / junction adjoining Forstal Road

## 4.2 TM/22/00186/FL Overflow Car Park Hermitage Court Hermitage Lane, Aylesford South

Permanent retention and altered layout of meeting pods and cafe, ancillary to the business use of Hermitage Court previously approved temporarily under TM/20/01805/FL. The use of overflow car parking spaces to provide for the static stationing of mobile MRI scanner units and associated structures to service the medical use (NHS) of the ground floor of Unit A at Hermitage Court
