#### 1. Declarations of Interest

Cllr Rillie declared an interest in applications 11 and 14 **Anchor Barn**, as a near neighbour. He took no part in the discussion and decision.

Cllr Mrs Gadd declared an interest in application 19. **25 Holtwood Avenue**, as the applicant is known personally to her. She took no part in the discussion and decision.

# 3. PLANNING APPLICATIONS

1.TM/16/00797 **Taddington Wood North of Robin Hood Lane, Blue Bell Hill**Outline application – erection of x 5 dwelling houses and x 5 detached garages with associated access parking and turning areas and landscaping. Ecological Scoping Report for information.

Parish Council Comments: APC's objection remains. Overdevelopment of site as per previously refused application. No additional amenities included.

2.TM/16/01239 **Holtwood Farm Shop, 365 London Road, Aylesford South** Permanent retention of fish van (TM/13/03491)

Cllr Homewood stated that he supported the applicant's previous application for permanent permission due to trading only 3 days a week, no cooking on site therefore no odours and in fairness there being no restrictions placed on the nearly restaurant which cooks 7 days a week and has traffic movement implications.

Cllr Balcombe stated that he is aware of continued complaints from local residents about this business. They are disturbed by odours and noise from customers. The applicant has over run the period of time his temporary permission was granted by several months thereby gaining extra time. Cllr Balcombe further stated that if permission is granted he would prefer to see it for a limited period again so that control can be maintained.

Parish Council Comments: Strong Objection. We are still aware of residents' complaints amount smells from the van and noise from customers.

#### 4. DETERMINATIONS DIFFERING FROM PARISH COUNCIL COMMENTS

TM/16/00021 **Kent House, Ditton Court, Quarry Wood** – New cold store and ancillary office link to existing building. APC objection due to traffic implications. TMBC decision – Approved.

TM/16/00931 **20 Roman Close, Blue Bell Hill** – Tree works. APC objection well established trees with no reason given for felling. TMBC decision – Approved.

TM/16/01311 **235 Woodlands Road, Aylesford** – Tree works. APC objection due to no Tree Office report (now received – see 3.3 above). TMBC decision – Approved.

#### 5. ANY OTHER BUSINESS/CORRESPONDENCE

- 1. Aylesford Newprint Site Public exhibition held on 1<sup>st</sup> and 2<sup>nd</sup> July. Clerk is in receipt of details published at the exhibition. Available from the Parish Office. Proposals are 450 houses and 120,000 ft of industrial use. APC's view on the opening of Bellingham Way is that it should be investigated but there are concerns its opening would exacerbate the A20 problems rather than solve them. The Council would expect to see a transport plan for this application.
- 2. TMBC Draft Local Plan goes before the TMBC Committee this evening. Consultation with Parish Council's expected in September.
- 3. Cllr Wright stated his concerns at the poor standard, or non-existence in some cases, of site plans received with recent applications. This was making constructive comments difficult in some cases.
- 4. Other Councillors also stated they would like to see the comments from other consultees/neighbouring properties on applications. Clerk advised this was unlikely unless the consultee copied the Parish Council into their comments as all consultees (including the Parish) are contacted at the same time with the same time scale for responses.
