## 6.1 - TMBC 5 Year House/Land Supply

Clerk reported on his correspondence with Steve Humphrey at TMBC regarding the 5 year house/land supply and the new Local Plan progress.

TMBC had stated that their 2017 Annual Monitoring Report showed a shortfall of 199 dwellings in the current 5 year housing land supply within the Local Development Framework rather than in previous years which had shown a surplus. The impact of this change means that whilst planning applications will continue to be determined in the light of the adopted policies in the LDF the primary consideration will also be the contribution the development could make to the 5 year housing land supply and this consideration would outweigh any reasons for refusal.

In respect of the Local Plan, the Government consultation document 'Planning for the Right Homes in the Right Places' could see a further increase in the current housing need in the TMBC area over the next 20 year plan period up to 159 a year and 3260 over the 20 year period. A full and robust response to the Government has been made and overall this has delayed the timetable for the new Local Plan. Public consultation is now anticipated in the summer of 2018 with the aim to adopt the new Local Plan in 2019.
