Retrospective application for: Part demolition of front of existing garage and extension to the rear of garage for food preparation for BBQs and dogs needs. Retention of rear outbuilding to house applicants personal dog collection, with access to play/exercise area.

## 21. TM/17/03000 2 Holtwood Avenue, Aylesford South

Cut leylandii trees to a height of 8ft.

Parish Council Comments: No objection

#### 22. TM/17/03027 **20 Sadlers Close, Walderslade**

Oak – reduce crown by 25% (3-4 metres)

Parish Council Comments: Objection. There does not appear to be any reason to alter this tree as it is 1. Not diseased; and 2. Not affecting the property badly. Its reduction would be detrimental to the street scene.

## 23. TM/17/03093 1, 2 and 3 Falkland Place, Walderslade

Sweet chestnut, common hawthorn, sweet chestnut, beech – cut back growth to boundary by approx. 1-2 m. Hawthorn (small and overhanging adjacent gardens) – fell to ground level. Holly (too close to boundary) – fell to ground level. Hazel – cut back growth to boundary by approx.. 1-2m. Unknown (ivy covered, poor specimen) – fell to ground level. Group of hazel – cut back to boundary by approximately 1-2m.

Parish Council Comments: Objection. Applicants can already trim back to the boundary without such radical pruning as described.

## 24. TM/17/03121 10 Holtwood Avenue, Aylesford South

2 leylandii – fell to ground. Monteray Cypress – fell to 4ft. Cherry – reduce to 5ft. Cypress – lift to 4.5m.

Parish Council Comments: No objection
