3. PLANNING APPLICATIONS

1. TM/14/01421 Waitrose Distribution, Beddow Way, Aylesford North

Installation of 14 new loading bays/docks and erection of fencing to side and front of site. Additional information received: Technical information, contamination technical note, flood risk assessment and proposed floor plan.

Parish Council Comments: The Parish Council has no objection in principle to the installation of the new loading bays/docks. However it does have concerns as to whether the proposed acoustic fencing is adequate and high enough to protect local residents from environmental pollution, particularly noise, arising from this new development. There is also an issue that the fencing runs along the boundary of existing bridleway MR471 so unexpected noise from the site could spook horses

Proposed two storey rear extension, demolition of garage and erection of two storey side extension and internal alterations. Amendment to TM/13/02650
