# PLANNING COMMITTEE MINUTES

1. **Declarations of Interest** – There were no declarations additional to those contained in the Register of Members' Interests.

## 2. Apologies

Cllrs: Ambrose (ill wife); Balcombe (TMBC meeting); Base (holiday); Mrs Brooks (caring for elderly relative); Fielder (ill); Homewood (KCC business)

Apologies and reasons were noted and accepted.

## 3. Adjournment of Meeting

The Chairman sought the agreement of the Committee to adjourn the meeting to allow the members of the public present, Mr Brewood and one other, to address the Committee with their views on the Rochester Airport applications which were before the Committee this evening (see 8. and 19. below). **Agreed** 

Mr Brewood read a statement which is summarised below.

- Thank you for the opportunity to address the meeting.
- The current grass runway can take up to 30,000 movements per year. The proposed paved runway could take up to 100,000 movements per year.
- Medway Council have stated it will be 40,000 movements but this is flexible and renewable so there is no guarantee this amount will not be exceeded
- There is no protection built into the application for local residents
- There has been no Environmental Impact Assessment (EIA) done
- He believes Medway Council have acted illegally in the way they have undertaken this application
- The drawings presented are not fully detailed
- This is a public project on which there has been no prior public consultation

• He would encourage Aylesford Parish Council to object to the proposals based on their being no powers included in the application to safeguard local residents, that use of the paved runway will be exploited, there has been no EIA, the adverse impact on the local community, Medway Council's dismissal of fatality figures, no public consultation and local property values will be affected.

The Clerk summarised the content of the applications received (see 8. and 19. below):

- New paved, lit runway which will enable aircraft to gain height quicker
- Closure of existing runway
- New office/café/viewing buildings
- New hangars and hangar type buildings
- New memorial garden and viewing area
- Land east of hangers left open for future development if/when required
- Limit of 40,000 movements per year
- Hours reduced from 24 hours to 12 hours weekdays/9 hours weekends and bank holidays apart from home based aircraft who can use it up to 2100, emergency and military aircraft and limited pre-arranged out of hours movements

In answer to Cllr Smith, Mr Brewood stated he was representing only himself at the meeting this evening. The other member of the public present stated that he co-ordinated the distribution of a newsletter on the subject of the airport to approximately 1400 interested people.

The Chairman thanked the Members of the Public for their attendance and participation and reopened the meeting.
