12. TM/13/02833 79 Woodbury Road, Walderslade

Hornbeam – Raise crown to 4 metres and reduce overall crown by a third. Sweet chestnut – reduce to fence height to match neighbours tree

13. TM/13/02837 36 Birch Crescent, Aylesford

Fell 1 no. birch tree suffering from die back

Parish Council Comments: No objection

14. TM/13/02596 11 Elm Walk, Aylesford

Details pursuant to conditions 2 (materials), 4 (slab levels) and 7 (storage and screening of refuse) of TM/11/03390 (New detached dwelling with associated parking and ancillary outbuilding with solar panels)

15. TM/13/02637 Land at 203 London Road and 2-16 Hermitage Lane, Aylesford

Demolition of 8 C3 residential bungalows and redevelopment to provide 3 A1 retail units and 1 A5 fast food/taleaway unit, car and cycle parking, vehicular access, pedestrian access and associated landscaping

Proposed two storey rear extension, side extension and internal alterations

Insertion of two flat roof dormers to the front and rear roof elevations on the existing outbuilding to accommodate a play room in the loft space

A. Reduce silver birch no. 1. B. Reduce silver birch no. 2 and remove branches over footpath. C. Reduce and shape sycamore no. 3 and remove branches overhanging Gorse Crescent.

Parish Council Comments: No objection

19. TM/13/02950 Silver Birches, 425 London Road, Ditton (on boundary)

T1 and 2 Lawson Cypress – Fell, poor form and low amenity value. T3 Ash – Reduce crown by 20% and remove deadwood. T4 False Acacia – remove dead wood and large low hanging bower. T5 Hazel coppice – grub out and replace with beech hedge. T6 silver birch – fell, suppressed form and low amenity value. Replant felled trees with 3 himalayan silver birch. T7 Sweet chestnut group – lift crown to clear street lamp, remove smaller growth from base. T8 Hornbeam – Fell, poor form and low amenity value. Replace with beech hedging. T9 Oak – remove deadwood and lift crown to 5m. T10 Cypresses – fell, stem splaying, unable to support itself. T11 silver birch – fell, suppressed form, allow more light to adjacent healthier

20. TM/13/02694 Land to Rear of 4 Roman Close, Chatham Oak tree – reduce spread by 25%

Parish Council Comments: No objection
