1. TM/14/02105 **160 Bull Lane, Eccles**

Construction of an attached dwelling. Additional drawings.

Parish Council Comments: Objection. The additional drawings show 2 windows in the front roof area. The original adjacent 6 residences have 2 storey frontages and therefore these plans do not conform with the current street scene.

2. TM/14/02164 Land at Warren Road, Blue Bell Hill, Chatham

Erection of a stable block and the change of use of land for the keeping of horses. Additional information regarding manure storage and surface water disposal.

Many people visit this but there is no safe path or nearby car parking. If three or four car parking spaces could be provided just north of the new entrance it would benefit the visitors and also reduce the likelihood of them parking in or across the new entrance. Perhaps English Heritage would contribute towards the cost of this? If would be safer if the 40mph speed limit on Rochester Road could be extended to north of the proposed entrance.
