1. Apologies for Absence

4. Planning Applications

4.1 TM/23/00792/FL – 50/52 High Street Aylesford North

Change of use from A3 (Restaurant) to C3 (Residential) with no external changes to the building

It was Agreed to raise No Objection

4.2 TM/23/00793/TPOC - 20A Sycamore Drive Aylesford South

Applicants ref T1 - Holly standing in G1 of Tree Preservation Order – Reduce overall crown size by approx 30%, due to excessive overshading and size of tree for the space its in.

4.3 TM/23/00795/FL - 29 Sedley Close Aylesford South

Conversion of detached garage to habitable room and pitched roof extension to provide additional first floor accommodation (Revision to TM/22/02538/FL)

4.4 TM/23/00797/TNCA - 218 Woodlands Road Aylesford South

G1 Beech (applicant reference) Reduce in height by 8m (previously pruned approx 15 years ago). There is vermin damage in the upper crown which has led to branch failure (snap outs)

4.5 TM/23/00403/FL - 79 Rochester Road Aylesford North

Proposed detached outbuilding and carport (retrospective)

It was **Agreed** that the Council cannot make a comment at the moment due to a number of questions being raised by members with regards to the original planning permission that was granted for the two dwellings in 1988 that states there was a landscaping condition for the area in question that now houses the outbuilding and carport. The Council asked the Clerk to make some enquiries with TMBC so it can make an informed comment on this retrospective planning application. **Ongoing**

4.6 TM/23/00837/FL- Cherry Bungalow 351 Pratling Street Aylesford

Proposed erection of new two-bedroom bungalow
