1. **Declarations of Interest**

Cllr Tiller declared an interest in item 10. TM/14/02213 as the applicant and took no part in the discussion or decision.

3. **PLANNING APPLICATIONS**

1. TM/14/01105 **7 Rowan Close, Aylesford South**
Demolition of existing double garage and construction of 3 bedroom detached dwelling with associated parking

Parish Council Comments: No objection

2. TM/14/01856 **Unit 1B Burnt Ash Road, Quarry Wood, Aylesford South**
One externally illuminated fascia sign to the southern elevation and two non illuminated signs to the northern elevation. Amended proposal description

Roof details relation to conversion of Preston Hall to 36 dwellings under TM/14/01611.
Amended details submitted indicated revised eaves detail

4. TM/14/02055 **10 Walsham Road, Walderslade**
Silver birch – reduce eastern branches to clear building by 2m; Hornbeam – coppice eastern stem due to close proximity to buildings. Reduce remaining canopy by 30%; Sweet chestnut – coppice and allow to regenerate. Amended proposal description

Parish Council Comments: No objection

5. TM/14/02098 **27 Sheraton Court, Walderslade**
Proposed 2 storey rear extension to form dining area at ground floor and bedroom 4 at first floor level. Existing conservatory to be demolished

Parish Council Comments: Strong objection. This is overdevelopment of a site with a very small garden. In April 2013, despite Parish Council objections, TMBC granted permission for the removal of an oak tree because it was too close to the house. There is a second mature oak in the garden which would be closer to the extension than the original was to the house.

6. TM/14/02158 **308 Robin Hood Lane, Blue Bell Hill**
Thin canopy by 25%. Prune back limb (2-3 m) which overhangs neighbour to fence line. Prune back limb which overhangs side entrance by 2–3 m. Remove all major deadwood. Lift the canopy to crown break.

Erection of a stable block and the change of use of land for the keeping of horses
